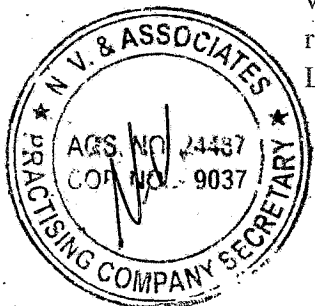

Dear Sir,

1. I, CS Nisha Verma, Practising Company Secretary, have been appointed as Scrutiniser by the Board of Directors of TCFC Finance Limited ("the Company") at its meeting held 13th May, 2024, for the purpose of scrutinising the remote e-voting and for conducting e-voting at the 33rd Annual General Meeting ("33rd AGM") and ascertaining the requisite majority on remote e-voting and e-voting at AGM, carried out as per the provisions of section 108 of the Companies Act, 2013 ("the Act") read with rule 20 of the Companies (Management and Administration) Rules, 2014, as amended by Companies (Management & Administration) Amendment Rules, 2015 ("the Rules"), on the resolutions contained in the notice of the 33rd AGM of the Equity Shareholders of the Company, held on 30th July, 2024 through two-way video conferencing ('VC') or other audio-visual means ('OAVM').
2. The management of the Company is responsible to ensure the compliance with the requirements of the Act and the Rules relating to voting through electronic means and two-way video conferencing ('VC') or other audio-visual means ('OAVM') on the resolutions contained in the Notice of the 33rd AGM of the members of the Company. My responsibility as a scrutiniser for the e-voting is restricted to ensure that the voting process, both through the remote e-voting and e-voting at the meeting are conducted in a fair and transparent manner and to make a consolidated Scrutiniser's Report of the votes cast "in favour" or "against" the resolutions stated in the notice, based on the reports generated from the e-voting system provided by National Securities Depository Limited ("NSDL"), the authorised agency to provide e-voting facilities.



3. The 33rd AGM of the Company was held on Tuesday, 30th July, 2024 at 11.00 a.m. through two way Video Conferencing ('VC') or other audio visual means ('OAVM') and the voting for the resolutions was transacted as per the Notice convening the 33rd AGM, which was only through remote electronic voting process and electronic voting during the 33rd AGM in compliance with the applicable provisions of the Act (including any statutory modification or re-enactment thereof) read with Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended from time to time, and the Circular No. 14/2020 dated April 08, 2020, Circular No.17/2020 dated April 13, 2020 issued by the Ministry of Corporate Affairs followed by Circular No. 20/2020 dated May 05, 2020 and Circular No. 02/2021 dated January 13, 2021, Circular no. 10/2022 dated December 28, 2022 ("MCA Circulars"), Circular no. 09/2023 dated September, 25, 2023 ("MCA Circulars") has permitted to conduct the Annual General meeting through video conferencing ("VC") or other audio-visual means ("OAVM") up to September 30, 2024 and Securities and Exchange Board of India ("SEBI") Circular no. SEBI/HO/CFD/CMD1/ CIR/P/2020/79 dated May 12, 2020, Circular no. SEBI/HO/ CFD/CMD2/CIR/P/2021/11 dated January 15, 2021 and Circular No SEBI/HO/CFD/CMD2/CIR/P/2022/62 dated May 13, 2022 and all other relevant circulars issued from time to time, physical attendance of the members to the AGM venue is not required and general meeting be held through video conference (VC) or other audio visual means (OAVM).
4. Pursuant to the MCA and SEBI circulars, the Notice of the 33rd AGM and the statement setting out material facts under section 102 of the Act in respect of the respective resolutions proposed at the 33rd AGM along with the Annual Report for financial year 2023-24 was sent in electronic form only to those Members whose email addresses are registered with the Company/Depositories. The Notice calling the 33rd AGM had been uploaded on the website of the Company at www.tcfcfinance.com. The Notice can also be accessed from the websites of the Stock Exchange i.e. BSE Ltd. at www.bseindia.com respectively and the notice of the 33rd AGM is also available on the website of National Securities Depository Limited ("NSDL"),(agency for providing the e-voting facility) i.e. www.evoting.nsdl.com
5. Since the 33rd AGM was held pursuant to MCA Circulars pertaining to holding of the meeting through VC or OAVM, physical attendance of the members had been dispensed with. Accordingly, in terms of the above-mentioned MCA and SEBI circulars, the facility for the appointment of proxies by the members was also dispensed with.
6. The members attended the meeting through VC or OAVM were counted for the purpose of reckoning the quorum under section 103 of the Act.
7. Further to above, I submit my report as under:

- (1) The Company has provided the e-voting facility through NSDL on their website www.evoting.nsdl.com. The Company had uploaded all the items of businesses to



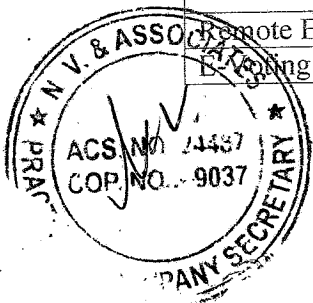
be transacted on the website of the Company and also its Service Provider to facilitate their shareholders to cast their votes through e-voting.

- (2) The notices were sent through email and they contained the detailed procedure to be followed by the members who were desirous of casting their votes electronically as provided under Rule 20 of the Companies (Management and Administration) Rules, 2014.
- (3) As prescribed in the said Rules, the Company has also published the advertisements on 27th June, 2024 and they carried the required information as specified in the said rules.
- (4) The Members holding shares or beneficial interest in the shares, as on 23rd July, 2024, ("cut off date"), were entitled to vote on the resolutions stated in the Notice of the 33rd AGM of the Company.
- (5) The e-voting was commenced from 26th July, 2024 (9.00 a.m.) and ended on 29th July, 2024 (5.00 p.m.) and NSDL e-voting platform was blocked in due time. After the closure of the voting at the 33rd AGM the report on voting done through electronic voting system at the meeting was generated in my presence and the voting was diligently scrutinised.
- (6) The votes cast under remote e-voting facility were unblocked on 30th July, 2024, in the presence of two witnesses, who are not in the employment of the Company.
- (7) The e-voting data was scrutinised by me for verification of votes cast in favour and against of the respective Resolution.
- (8) Thereafter, the details containing, inter alia, list of Equity Shareholder, who voted "for", "against" each of the resolutions that were put to vote, were generated from the e-voting website of NDSL i.e. <https://www.evoting.nsdl.com> The result of the e-voting exercised and the votes casted through electronic voting at the 33rd AGM is as under:

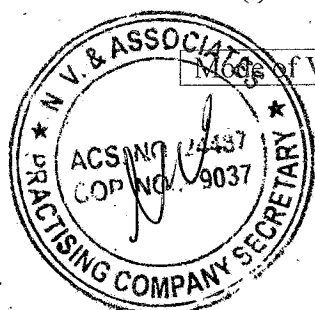

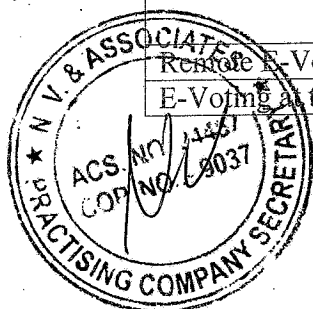

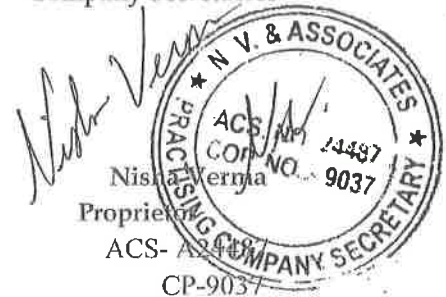
